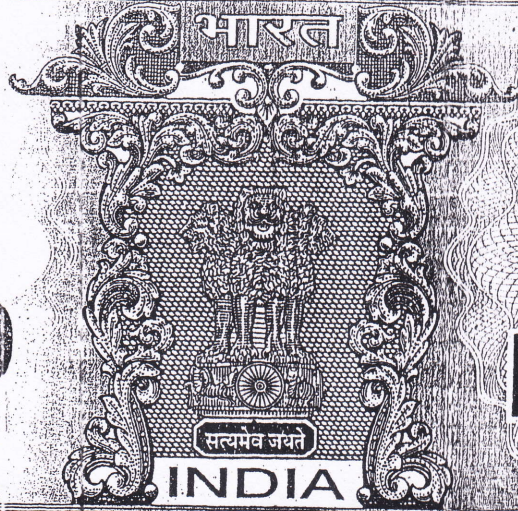

Dhara Rani, Sri Ragendra Swarup, Smt. Mini Swarup and Sri Ajai Kumar Saraogi, hereinafter called the trustees investing the subject matter of the trust in the trustees under this deed as setforth herein. WHEREAS the settlor is desirous of establishing a public charitable trust; and

WHEREAS a sum of Rs. 2,500/- (Rupees Two Thousand Five Hundred only) has been settled by the aforesaid Sri Ragendra Swarup on the said trust from out of his individual funds; and WHEREAS the settlor has deposited the said sum of Rs. 2,500/- (Rupees Two thousand five hundred only) with the Punjab National Bank, Civil Lines, Branch Kanpur and has entrusted the trustees aforesaid with the management and control absolutely of the said trust funds; and WHEREAS the settlor aforesaid has settled the ----- (Sd. Ragendra Swarup) ----- Page No. 3 ----- said sum of Rs. 2,500/- (Rupees Two Thousand Five Hundred only) on the said trust irrevocably; and WHEREAS the trustees above-named are willing to be invested with the ownership of the said money for the purpose of carrying out the objects of the settlor under the directions setforth herein so as to enable the trustees to execute the objects of the trust, according to the directions

1. In pursuance of the said desire of the settlor, the settlor hereby settles and assigns unto the trustees the said sum of Rs. 2,500/- (Rupees two thousand and five hundred only) to

3. That the objects of the said charitable trust are as follows:- (i) To establish and run schools and colleges and institutes etc., for the advancement of the learning of the public in general and to manager-----
